- Illustrated Standards

## **American Bloodhound Club Presenter/ Mentor Guidelines**

### **Criteria for becoming an ABC Presenter/Mentor:**

A.) Anyone wishing to become a presenter/mentor should submit an **application** to the ABC. Applications are reviewed by the Judge's Education Coordinators and referred to the ABC Board for approval.

B.) General requirements for becoming a Presenter/Mentor:

- 1) Be an ABC member in good standing
- 2) Have good communication skills
- 3) Have a pleasing, tidy, clean appearance
- 4) Have all dogs used in seminars in clean condition

C) Specific requirements for becoming a Presenter/Mentor

- 1) Have at least 10 years, preferably 15 years, of active Bloodhound exhibiting experience
- 2) Have at least 10 years, preferably 15 years, of active Bloodhound breeding experience
  - a) Only litters that are bred, whelped, raised, and evaluated by the applicant are included. Litters that are co-owned, but not whelped, raised, and evaluated by the applicant may not be included.
- 3) Have whelped at least 8 Bloodhound litters
  - a) Only litters that are bred, whelped, raised, and evaluated by the applicant are included. Litters that are co-owned, but not whelped, raised and evaluated by the applicant may not be included.
- 4) Have bred at least 10 Bloodhound champions
  - a) Only litters that are bred, whelped, raised, and evaluated by the applicant are included. Litters that are co-owned, but not whelped, raised and evaluated by the applicant may not be included.
- 5) Applicants who meet all the above guidelines should attend at least one seminar, preferably at a National Specialty, before submitting the application.

### **Responsibilities of an ABC Presenter/Mentor:**

#### **RINGSIDE TUTORING:**

A) The purpose of the ringside tutoring session is to provide the student judge an opportunity to observe a larger number of dogs in a short amount of time. This also allows them to realize the diversity of type within the breed which is acceptable under the AKC/ABC Bloodhound Standard.

B) It is vitally important that presenter/mentors who give a seminar and who assist with ringside tutoring sessions present the breed in a positive manner. This is quite a responsibility and not an easy task, as you might have to contradict what you have in your backyard.

C) It is vitally important that presenter/mentors who give a seminar and who assist with ringside tutoring sessions avoid any hint of bias toward or against any line or type.

D) The result of the seminar/tutoring should be that the student judges leave the session with a clearer impression of the breed and a great appreciation of this remarkably versatile dog.

- 3) Equipment (projection equipment or any audiovisual equipment)
- 4) Dogs to examine

#### NATIONAL SPECIALTY:

##### A) Work out details with the Show Committee

- 1) Date and Time
- 2) Meeting room
- 3) Equipment (projection equipment or any audiovisual equipment)
- 4) Dogs to examine
- 5) Refreshments
- 6) Private area for hands-on tutoring
- 7) Ringside seating for tutoring

##### B) Advertising

- 1) AKC Gazette and AKC web site listings (contact AKC)
- 2) Send flyers to Judge's Education Groups
- 3) Send flyers to judges and study groups in surrounding states
- 4) Post all information on the Judges' Education page of the ABC website

##### C) Materials

- 1) Provide all participants with an Illustrated Standard (available from Judges' Education Coordinator, Anne Schettig- [c1ddy@aol.com](mailto:c1ddy@aol.com) or 814-886-2371)
- 2) Provide a Schedule of Events to include all judging times
- 3) Respond to all judge's inquiries and provide information about the seminar (date, time, directions, lodging and meal information, etc)

#### SEMINAR:

##### A) Discussion of Standard and /or outline

- 1) Have two or more breeders or breeder/judges for discussion. Hopefully, these people will be available for tutoring.
- 2) Try to hold the seminar in close proximity to the breed judging for discussion at ringside

##### B) Hands-on

- 1) Demonstration of the proper examination technique and gaiting
- 2) Have 4-10 dogs for examination. These dogs should exhibit the variety of types and characteristics seen in the show ring. If possible, choose Specials quality hounds.
- 3) Positive points emphasized, however people that provide dogs must understand that faults may also be identified
- 4) Student judges are encouraged to verbalize their assessments of the individual dogs using breed specific language

C) Ringside Tutoring

- 1) Mark off area
- 2) Provide seating arrangements with the best view of dogs
- 3) Tutoring during Best of Breed competition is preferred
- 4) One mentor for every 2-3 judges (maximum).
- 5) All individuals participating in any aspects of conducting a seminar must be approved in advanced by the person supervising the seminar.

D) Paperwork

- 1) Name tags for student judges and mentors
- 2) Certificate of Completion for all student judges
- 3) Keep records of student judges attending seminar, including name and all contact information. Also note which portions of the training each student completed (seminar, hands-on, ringside mentoring, etc). This information may be requested by AKC.
- 4) Accurately complete, sign, and date all AKC forms presented to you by the student.
