## **TRAILS:**

The trailing sites for these events offer a variety of terrains and distractions. The sites include county public parks, industrial/corporate parks, and commercial areas/malls. As always, spectators are welcome as long as they do not interfere with the main focus of the trials themselves. Trial participants and spectators should check in at the “Barn” daily for schedule and logistical information. Trial entrants will receive additional information & confirmation of their run times via email prior to the events.

## **DIRECTIONS:**

*To the Sleep Inn and Suites-* The hotel is off of I-85 at exit 49. Get onto Bruton Smith Boulevard. At the first light (Weddington Road) turn left. Turn left on Gateway Lane to the hotel.

*To Frank Liske Park from the hotel-* Head out the hotel and turn left onto Weddington Road. Drive approx. 1 mile, and turn right onto Pitts Road. Stay on Pitts Road until it ends. Turn left onto Roberta Road (approx. 1 mile). Turn right onto Stough Road. The park entrance sign will be on the left side of the road .34 miles. Follow the park signs to the “Barn”. Our weekend headquarters is the lower level of this building.
